

REMEMBER THE TIME – MJ IMPERSONATION DANCE CONTEST

COMPETITION RULES

1. Categories:
 - a. Solo Category
 - b. Group Category (Maximum 6 members)
2. Pre-registration will be closed on **12 August 2009**. Onsite registration on **16 August 2009 opens from 1pm to 2pm**, subject to limited capacity. Pre-registration is strongly encouraged.
3. All participants must sign and return the Indemnity Form(s) to the organiser. Participants below 18 years old are required to obtain a written consent of their parent / guardian and return the Contest Form duly signed by their parent / guardian, together with the Indemnity Form duly signed by their parent / guardian.
4. All participants must adhere to the competition dates scheduled.
 - i. Auditions : 16 August 2009, Sunday, 1pm.
 - ii. Semi-Finals : 21 August 2009, Saturday, 1pm.
 - iii. Grand Finals : 29 August 2009, Saturday, 3pm.
5. Only tracks from Michael Jackson's albums are to be used. All participants must provide their own tracks in CD format and bring along 2 copies. Participants to bring their own MD player and cables if MD format is used. No cassettes are allowed.
6. Duration:
 - i. Auditions: Performance **should not exceed** 1 minute for both Solo and Group Categories.
 - ii. Semi-finals and Grand Finals: Performance **should not exceed** 2 minutes for Solo Category and 3 minutes for Group Category.
7. Judging criteria:
 - i. Solo Category
 - a) Creativity and interpretation of music : 30%
 - b) Entertainment value : 30%
 - c) Dance techniques : 20%
 - a) Costumes : 20%
 - ii. Group Category
 - a) Creativity and interpretation of music : 30%
 - b) Entertainment value : 30%
 - c) Dance techniques and synchronization : 20%
 - d) Costumes : 20%
8. The judges' decisions are final and no correspondence will be entertained.
9. The organiser reserves the right to change the time, rules and regulations and judging criteria without prior notice.
10. All performing apparel and performances must not bear offensive/vulgar language or insignia.
11. The organiser, partners and sponsors shall be under no liability whatsoever to the participants, in respect of any loss, damage or injury suffered by the participants arising from or pursuant to her / his participation in the competition or for any loss, damage or injury to life or property sustained by the participant at any stage of the competition, unless such loss, damage or injury is caused by the organiser's partner's or sponsor's gross and willful negligence.
